OVERVIEW

Jevon has significant experience in leveraging motion practice and procedure throughout the litigation process, from early motions to dismiss to post-trial motions and appellate argument.

applicable standards of review to identify reversible legal issues, and a strong writing background to persuade judicial panels that the lower court got it right or wrong. Jevon's strong experience in these areas make him a "go-to" appellate lawyer.

Jevon has established himself as a thought leader in the Minnesota legal community. He co-authors four volumes of the Minnesota Practice Series—the seminal treatise on Minnesota law and procedure—including the *Minnesota Handbook of Courtroom Evidence* and *Civil Rules Annotated*. Jevon is a member of the Minnesota Supreme Court Advisory Committee on the Rules of Civil Procedure, and he is active as a speaker on court rules, appellate practice, and insurance coverage. He also regularly posts on LinkedIn regarding legal writing and courtroom practice.

Believing firmly in the importance of pro bono service, Jevon volunteers at the Minnesota State Law Library Appeals Clinic, and he was a member of the Maslon team that successfully vacated Douglas Tyrone Armstrong's death sentence on a post-trial habeas corpus appeal. Additionally, Jevon has reversed convictions for two criminal defendants in the Minnesota Court of Appeals on the basis that evidence was obtained in violation of the defendant's constitutional rights.

Jevon is also active in his community. He is a governing member of the Saint Paul Chamber Orchestra and a founder of Arts Roseville, which seeks to advance local arts and creativity. Before joining Maslon, Jevon served as a law clerk to the Honorable G. Barry Anderson of the Minnesota Supreme Court. Prior to law school he was a middle and high school choir teacher. In his spare time he enjoys singing with the Minnesota Chorale, biking, and performing home renovations.
