### OVERVIEW

David Suchar, a skilled trial attorney and former federal prosecutor, has represented clients in some of the most significant construction and insurance related matters in the country. He is a Fellow of the American College of Construction Lawyers and the American College of Coverage Counsel—one of three lawyers in the U.S. invited to join both organizations.

David was recognized by *Chambers USA* as one of six Minnesota lawyers ranked Band 1 for Construction (2026) and Best Lawyers as the 2026 Lawyer of the Year (top ranked attorney) for Construction Litigation in the Minneapolis region. He co-chairs Maslon's Band 1 ranked Construction & Real Estate Litigation Group. *Who's Who Legal/Lexology* named him one of nine U.S. attorneys to receive the 2026 Client Choice Award for excellence in construction law and described him as "an impressive trial lawyer whose practice spans the spectrum of construction matters from insurance to payment claims." David was also listed by Lawdragon in its 500 Leading Litigators in America ranking (2026) and Thomson Reuters® as a Stand-Out Lawyer (2026) based on its survey of more than 2,000 senior in-house counsel. David recently served as chair of The Trial Network, a professional network of trial lawyers from 22 leading law firms, including Maslon.

David has developed a niche national practice representing commercial policyholders in insurance coverage disputes, including on many of the largest construction projects and claims across the United States. insurance coverage issues, drawing from his experience on the Steering Committee for the ABA Forum on Construction Law's Division 7 (Insurance, Surety & Liens) and as contributing editor of *The Construction Lawyer*, the flagship ABA construction publication. In 2022, David took over as host of the ABA's "Construction Law Today" podcast series, after appearing as a guest for its two-part podcast on Insurance Coverage Issues in Construction Litigation. In addition, he was lead co-author for the insurance chapter in the ABA's decennial *Construction Defects* book (2021) and authored several insurance chapters in the ABA's *Construction Checklists* book (2022).

As a former federal prosecutor, David has also counseled and represented clients at trial and through all aspects of various government, administrative, and internal investigations. His experience includes criminal prosecutions, inquiries, and subpoenas from state and federal agencies.

David's in-court experience sets him apart from the crowd. He has acted as first-chair trial counsel for a variety of bench and jury trials in courts across the country. In addition to his work in the areas of construction and insurance coverage litigation and government and internal investigations, David has successfully litigated various high-end contract and commercial litigation matters.

Before joining Maslon, David served as an Assistant U.S. Attorney at the U.S. Department of Justice and successfully represented the United States as lead counsel in hundreds of contested hearings, several trials in federal district court, and oral arguments in the United States Court of Appeals.
